 Darby Project - The Darby Project is focused on one-on-one mentoring and is the core of all the programs we are establishing. We believe matching a veteran transitioning from active duty with a previously transitioned veteran as similar to each other as possible and in the same local community is key to improving the transition process. We want military service (branch, specialties, training, deployments, even injuries) as similar as possible and we also seek to match post-service interests. For example, a male, US Army Ranger communications specialist with deployments to Iraq and Afghanistan and an interest in IT might be matched to a US Army Ranger communications veteran of Panama who now owns a small IT business. Our expectation is for a minimum six month relationship meeting at least twice a month to focus on mentoring the new veteran through the transition process. Named after Darby's Rangers of WWII, this program is expanding outside of the initial focus on US Army Ranger veterans

**4b** (Code ) (Expenses \$ 3,888 including grants of \$ 1,500 ) (Revenue \$ 0 )  
 LEO Training - Law Enforcement Officer education on veteran issues and de-escalation tactics is the focus of our LEO program. In a two-hour presentation we teach officers about issues affecting veterans, how to identify and communicate with veterans, how to de-escalate a bad situation, and provide resources for them to call if they are unable to work through the situation. GallantFew has intervened in and de-escalated situations posing great risk to both LEOs and veterans

**4c** (Code ) (Expenses \$ 3,260 including grants of \$ 600 ) (Revenue \$ 0 )  
 Descendants of Sparta - Just as the famous 300 Spartans stood against hordes from the East thousands of years ago, the New American Veteran defends freedom from a similar enemy and as such very much identifies with the ancient Spartan warriors. The Warfighter Pledge (also called the Spartan Pledge) is a promise made between two combat buddies to maintain communication and find a mission to help other veterans. This has become a powerful anti-suicide campaign

(Code ) (Expenses \$ 3,909 including grants of \$ ) (Revenue \$ 0 )  
 SDVOSB Training - In 2004, President Bush signed a law setting aside 3% of the federal procurement budget to award to Service Disabled Veteran Owned Small Businesses. This is a great opportunity for an injured or wounded veteran to establish or grow a small business, but few that qualify know about the program and less about how to circumnavigate the process to certification. GallantFew identifies veterans that qualify, educate them on requirements and mentor them through the process to certification. In 2012, we partnered with the Kansas Small Business Development Center, and the GallantFew Executive Director was named the Veteran Small Business Advocate of the year for Small Business Administration Region VII
